I fully understand and appreciate the potential dangers, hazards and or risks, directly and or indirectly inherent in participating in this activity, which could also include the loss of life, serious loss of limb or loss of property.

I further understand that the School does not carry medical or liability insurance for me while I am participating in this activity. By placing my signature below, I acknowledge to the School that I have adequate medical and hospitalization insurance for any injuries that I may incur as a result of participating in this activity.
